THE CLUB IS OWNED IN ENTIRETY BY ITS MEMBERS.

## SUBSCRIPTIONS

ALL PLAYING MEMBERS MUST PAY SUBSCRIPTIONS AS FOLLOWS:

YOUTH PLAYERS - £80

JUNIOR PLAYERS - £115

FAILURE TO KEEP UP TO DATE WITH PAYMENTS COULD RESULT IN TEMPORARY SUSPENSION OF MEMBERSHIP OR HAVING MEMBERSHIP CANCELLED BY THE CLUB.

50% OF SUBSCRIPTIONS MUST BE PAID UPON REGISTRATION BEFORE THE START OF THE SEASON, WITH FEES PAID IN FULL BY THE 1<sup>ST</sup> JUNE 2018.

ADDITIONALLY ALL PLAYERS MUST INDEPENDENTLY PAY THEIR ANNUAL MEMBERSHIP FEE TO BAFA (FOR INSURANCE AND LIABILITY PROTECTION). THIS IS PAID UPON REGISTRATION VIA THE LEAGUE ONLINE REGISTRATION SYSTEM.

PLAYERS JOINING THE TEAM AFTER MID-SEASON MAY HAVE THEIR SUBSCRIPTION REDUCED BY THE CLUB TREASURER ON A PRO-RATA BASIS
